

NOTICE TO BIDDERS

1. Notice is hereby given that the governing board ("Board") of the Travis Unified School District ("District") will receive sealed bids for the following project:

SCANDIA ELEMENTARY SCHOOL PLAY STRUCTURE RELOCATION

The Project is located at 100 Broadway **on Travis Air Force Base** in Fairfield CA 94533.

Access to the BASE is restricted. See below for site visitation information/requirements

2. A general description of the Bid Package categories, and the State of California Contractor License classification(s) deemed acceptable for the category to bid, are as follows:

Relocation of existing Miracle Playsystems Inc. Play Structure from current location to new location on same campus. Work includes but is not limited to: Disassembly of existing play structure, storage for 1 year, re-installation of play structure and approximately 2,550sf of crushed stone base (4" thickness) and poured in place resilient rubber surfacing to meet 7' fall protection requirements

CA LICENSE CLASSIFICATION(S)] B or C61/D34

The Bidder's license(s) must remain active and in good standing throughout the term of the Contract.

3. To bid on this Project, the Bidder is required to be registered as a public works contractor with the Department of Industrial Relations. The Bidder's registration must remain active throughout the term of the Contract.
4. Contract Documents are only available at the Travis Unified School District Office's Portable Maintenance Building, 2751 De Ronde Drive, Fairfield, California 94533. Contact Jim Kordakis at 530-919-1642.
5. A pre-bid site visit is **MANDATORY**. Contact Jim Kordakis at 530-919-1642 to arrange a site visit. Attendees must possess a valid California driver's license, or other form of current government-issued identification. The last day to schedule a site visit is Thursday Mar 30, 2017
6. Trade Contractor bids shall be submitted in a sealed envelope marked "BID", identifying the Project. Any bid that is submitted after this time shall be non-responsive and returned unopened. District reserves the right to postpone the date and time for submission of bids.
7. Sealed Bids will be received only at the Travis Unified School District Office's Portable Maintenance Building, 2751 De Ronde Drive, Fairfield, California 94533 no later than

April 4, 2017 @ 2:00pm after which time the bids will be opened and publicly read aloud. Any claim by a bidder of error in its bid must be made in compliance with section 5100 et seq. of the Public Contract Code.

8. All bids shall be on the form provided by the District.
9. The successful Bidder shall be required to furnish a 100% Performance Bond and a 100% Payment Bond if it is awarded the contract for the Work.
10. The successful Bidder may substitute securities for any monies withheld by the District to ensure performance under the Contract, in accordance with the provisions of section 22300 of the Public Contract Code.
11. The Contractor and all Subcontractors under the Contractor shall pay all workers on all work performed pursuant to this Contract not less than the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work as determined by the Director of the Department of Industrial Relations, State of California, for the type of work performed and the locality in which the work is to be performed within the boundaries of the District, pursuant to sections 1770 et seq. of the California Labor Code. Prevailing wage rates are also available from the District or on the Internet at: <<http://www.dir.ca.gov>>.
12. This Project is subject to labor compliance monitoring and enforcement by the Department of Industrial Relations pursuant to Labor Code section 1771.4 and subject to the requirements of Title 8 of the California Code of Regulations. The Contractor and all Subcontractors under the Contractor shall furnish electronic certified payroll records directly to the Labor Commissioner weekly or within ten (10) days of any request by the District or the Labor Commissioner. The successful Bidder shall comply with all requirements of Division 2, Part 7, Chapter 1, of the Labor Code.
 - A. The District shall award the Contract, if it awards it at all, to the lowest responsive responsible bidder based on the base bid amount only.
13. The Board reserves the right to reject any and all bids and/or waive any irregularity in any bid received. If the District awards the Contract, the security of unsuccessful bidder(s) shall be returned within sixty (60) days from the time the award is made. Unless otherwise required by law, no bidder may withdraw its bid for ninety (90) days after the date of the bid opening.
