**Request for Auto/Motorcycle Parking Permit**  
**Rules and Regulations for Driving with a Valid Driver's License**

Dear Parents/Guardians/Students:

Parking privileges will be extended to students with a valid driver's license. Before a **FREE** student parking permit is issued, each student must meet the following list of rules and regulations and return the permission/registration portion of this document to the ASB Office. Students must have a valid driver's license BEFORE applying for a free parking permit.

1. Student drivers must present a **valid driver's license, car registration, and automobile insurance card** at the time of permit registration. A Free parking permit **WILL NOT BE ISSUED** until these documents are presented!
2. A permit **WILL NOT BE ISSUED** if the student has outstanding fees owed to the school and/or the District. The permit may be revoked if new fees remain unpaid.
3. Students must exercise extreme caution when entering or exiting the parking area. Speeding and /or reckless driving is prohibited and may result in revocation of driving and/or parking privileges.
4. Under no circumstances may a student go to his/her car during the day without permission.
5. Students with excessive tardies and/or absences may lose their parking privileges.
6. Parking spots are on a first-come, first-served daily basis, just because you had the spot today does not mean you will have the same spot tomorrow.
7. The parking permit (placard) is to be placed on the dashboard or hung from the review mirror.
8. All California traffic laws pertaining to driving and auto maintenance will be enforced.
9. All drivers are expected to yield to school buses and pedestrians. Both always have the "right of way."
10. Violations of the above stated rules and regulations and/or observations of driving behavior that is deemed unsafe or inappropriate by administration will result in suspension or revocation of parking privileges.
11. While efforts are made to monitor the parking lot, students are reminded that parking is at their own risk.
12. If there are any changes please (Driver's License, Car registration, and Automobile Insurance, or Multiple vehicles) please bring copies of changes to ASB Office as soon as you can. THANK YOU!
